Terms and requirements of being a member:

Changing Membership Type: Members may request to change their membership type by submitting the appropriate form to Wickertree Membership coordinator.

Abiding by club rules and regulations: All members are expected to follow the club's rules and regulations, such as court reservation policies.

Non-Refundable Fees: Membership and Enrollment fees are not refundable.

Membership Renewal and Cancellation: Members must adhere to all policies, rules and procedures of Wickertree Tennis, which may be subject to change without notice. Membership will renew automatically on an monthly basis. Members may cancel their membership by giving 30-days' notice and completing a Membership Termination Form.

Administrative Fees: A \$25 fee will be added to a member's account if any form of payment is returned for any reason.

Guest Policy: Members may bring an unlimited number of non-members, with a guest fee.

Cancellation Policy: Wickertree Tennis requires 24-hour notice for canceling court reservations, lessons, and clinics. Members will be charged a fee if sufficient notice is not provided.

Address and Communication: Members must inform Wickertree Tennis of any changes to their email, address, phone number, or name.

Health Warranty: Members confirm that they are physically fit to participate in all activities at Wickertree Tennis and understand the associated health risks.
